**COMPLETE RELEASE OF LIABILITY AND INDEMNITY AGREEMENT
FIELD INSTITUTE OF TAOS**

The undersigned, is the parent or guardian of _____

(hereinafter referred to as the "child"). In exchange for the Field Institute of Taos making the NATURE ADVENTURE! OUTDOOR EXPLORE! ADVANCED ADVENTURE! GIRLS AS LEADERS! MOUNTAIN BIKE CAMP! JUNIOR COUNSELOR and COUNSELORS IN TRAINING programs (hereinafter referred to as the "programs") available and Taos Ski Valley, Inc. making its facilities available, the undersigned hereby contracts and agrees as follows:

For myself and the child, the undersigned agrees and understands that outdoor activities may be hazardous and may result in injury to my child during his/her participation in the programs. Trail conditions and weather vary constantly. I hereby assume all risks in connection with my child's participation in such activities (including all transportation), without limitation, and hereby promise not to sue and completely release the Field Institute of Taos and Taos Ski Valley, Inc., its representatives, agents, affiliates, officers, directors, servants, and employees from all liability for any injuries or damages and from any claim or legal action by me, any other parent or guardian of the child, the child, anyone on behalf of the child and by the estate, heirs, and assigns arising in any way from my child's participation, including any claim.

The undersigned further authorizes the Field Institute of Taos or Taos Ski Valley, Inc. to call for medical care for my child or to transport my child to the appropriate clinic or hospital if, in the opinion of anyone, medical attention is needed for my child. The undersigned agrees to pay all costs associated with such medical care and related transportation for the child and indemnify and hold the Field Institute of Taos and Taos Ski Valley, Inc., its representatives, agents, affiliates, directors, servants, and employees harmless from any costs incurred therein, or any claims arising therefrom.

In exchange for, and in consideration of, the Field Institute of Taos making its programs available and Taos Ski Valley, Inc. making its facilities and the ski area available, I contractually agree that any and all disputes will be governed by the laws of the state of New Mexico and the exclusive jurisdiction thereof will be in the state for federal courts of the state of New Mexico.

I hereby grant Field Institute of Taos, its agents, representatives and assigns, the absolute right and permission to use, sell, and publish photographs of my child.

I have carefully read the foregoing complete release of liability and indemnity agreement and understand its contents, including the jurisdictional agreement. I acknowledge and understand this is a complete release and indemnity agreement, that it includes any and all claims by the child or by me or by anyone on the child's behalf for any reason.
